

## Honorable Ambassador of the United States of America in Austria, Mr. Trevor Dow Triana, Dear Excellency,

As was recently reported in various news sources, including the Boston Globe on June 30th, 2019 the best-known agent of the Iranian Regime in the US, Mr. Trita PARSI, has now teamed up with the Koch Brothers and George Soros to establish the "Quincy Institute for Responsible Statecraft"

Given the background of Mr. Parsi as a shadowy but consistent lobbying agent for the IRI regime - until recently at the "NIAC" lobby, it can be safely assumed that the new-found funding sources will allow the Iranian Regime Lobby to redouble its efforts in countering the realistic US foreign policy approach taken by the esteemed current US administration.

As stated, Trita Parsi, was head of the National Iranian American Council" (NIAC)

The Founder of the Iranian-American Council, which itself was closely related to the Islamic regime in Iran, Mr. Houshang Amir Ahmadi a former patron of Trita Parsi, said in an interview that NIAC and Trita Parsi were closely collaborating with Iranian Foreign Minister Javad Zarif.

NIAC declares itself without any proof as a representative of millions of Iranians in America. The lobby activity of the NIAC was confirmed in a court case by judgment in the US.

The overwhelming majority of Iranians correctly assume that Mr. Parsi and his organization lobbies in the US to advance the interests of the Islamic government in the United States while hiding their true intentions to all other parties.

In this context, we request an investigation into whether NIAC violated FARA regulations.

Now it is possible that NIAC will be overtaken in its role as a representative of the Islamic Government by the QIRS under the leadership of Mr. Trita Parsi while continuing furthering the IRI Regime's agenda whilst abandoning the well-established "NIAC" Lobby identity

At this point, we ask the founders of the Quinsy Foundation how they see supporting Trita Parsi and his pro-Regime agenda can be associated with the aspiration of "responsible statecraft".

Apart from internal oppression, the Islamo-fascist regime in Iran has been the cause of many conflicts in the region for 40 years, and was from the outset a terrorist regime that was able to secure its existence only by violence, taking hostages and suppressing its own population.

The Iranian National Solidarity in Vienna hereby wishes to announce in the name of the oppressed Iranian people that the "Quincy Institute for Responsible Statecraft" and its apparent lobbying objectives are against Iranian national interests, and -we may add, the United States 'as well.

Furthermore, we would like to stress that the lobby activity of this Organization in the US for the regime in Iran not only endangers the security of your country, but is indirectly also a danger for the World peace considering, for instance, the recent acts of piracy by the IRGC Navy in the Persian Gulf.

We ask the brothers Koch that they investigate the past activities of Mr. Trita Parsi and his evident record as a full-fledged IRI lobbyist and reconsider their decision to cooperate with this person.

Trying to accommodate the IRI regime proved futile time and again, the Khomeinist regime was emboldened each time it was appeased, as visible with the vast proliferation of and support to terrorist militias throughout the Middle East since the signing of the JCPOA.

The clearest way to support peace, stability and rule of law in Iran and the Middle East is to weaken the oppressive IRI regime in such a way that a secular democratic Iranian uprising becomes inevitable.

Having the US and the free world's support in Iran's fight against the mullah regime to establish a Democratic Secular System is instrumental in this phase of the Islamic Regime's visible and progressing decline.
